- Mike welcomes group
- Committee members present introduced themselves
- New attendees were recognized
- This meeting in person only with a more in-depth virtual meeting to follow at a later time

- Mike presented overview of Committee activities including scope, leadership, and activities
 - How to get involved: QR code to web page; get on mailing list; volunteering
 - Committee composition: diversity, gender, race, employer type, geography
 - Committee members go into MyTRB and update demographic info
 - Succession planning for 2023 rotation; TSP and paper review handoffs
- All three subcommittees had/will have virtual meetings
- Jim Huddell summarized Workshop 1023
 - o 50 people attended with animated discussion
 - Share achievements, get conversations started. Ohio DOT very involved workforce development
 - Key themes included budget limitations, on job training/time to learn on job, policies restrict some questions, research and resources needed, and documentation what types of training, etc.
 - o Mike indicated research priorities could be discussed in virtual meeting

 - Urban Area Criteria for 2020 Census (Jennifer Zanoni)
- AED20(2) Big Urban Data Subcommittee (Mike for Vince Bernardin and Zak Patterson)
 - 19 papers submitted to AED20(2): 11 for Presentation and Publication and 8 for Presentation
 - Unlike last year only a handful dedicated to COVID impacts
 - 2 accepted for Presentation and Publication and 9 for Presentation
 - o Papers presented in Poster Session 1414 Big Urban Data Applications
 - NCHRP problem statement privacy vs. data loss
- AED20(3) Travel Time, Speed and Reliability Joint Subcommittee (with ACP70) (Mei Chen and Sam Granato)
 - o Considerably fewer papers this year with more reviewers
 - 50-55 papers some years down a little bit up to 8
 - Subcommittee virtual meeting will be 2/2 select best paper/award certificate
 - Two Research Needs Statements (RNS) funded recently with project oversight meetings just getting started
 - A third RNS "Communicating Travel Time Reliability: Analytics and Visualization Methods" is up for funding review

 - Have volunteer opportunities paper review coordinator, looking for State DOT RNS and NCHRP process experience

 - Theoretical yet practical RNS submitted to NCHRP with State DOT/CIO support
